1 RULES

- 1.1 The Organizing Authority is Coconut Grove Sailing Club
- 1.2 The regatta will be governed by the rules as defined in The Racing Rules of Sailing
- 1.3 The SCIRA Rules of Conduct to be used shall be the SCIRA Rules of Conduct For Conducting National and Local Regattas.

2 ELIGIBILITY AND ENTRY

- 2.1 Eligibility is defined by the Snipe Class International Racing Association (SCIRA).
- 2.2 Eligible boats may enter by completing the entry form at the Coconut Grove Sailing Club during the stated times for registration.
- 2.3 Registration and payment of entry fee must be completed no later than 1000 on Friday March 19, 2010.

5 SAILING INSTRUCTIONS

Sailing Instructions will be available at registration.

6 VENUE

The regatta will be on Biscayne Bay in the vicinity of the entrance to Brennan's Channel.

7 COURSES

- 7.1 The courses will be Windward-Leeward, Olympic, or Triangle.
- 7.2 Variant courses utilizing downwind finishes may also be used.

8 SCORING

- 8.1 One race is required to be completed to constitute a series.
- 8.2 Should the conditions make it impossible to complete the scheduled number of races, the regatta will be terminated and the results based on the races completed and scored.
